The franchisee will establish and operate a business operation that provides the sale and service of landscape lighting products, installation and services that use our proprietary system and marks (the "Landscape Lighting Business").

The estimated total investment necessary to begin operation of a Landscape Lighting Business ranges from \$52,890 to \$109,255 (see Item 7 for details). This includes \$28,250 to \$49,500 that you must pay to the franchisor or affiliate (see Item 5 for details).

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
