As a LIME Painting™ franchisee, you will operate a business that utilizes a distinctive selling system to offer and sell painting and substrate services to designated residential and commercial customers, and that may coordinate with sub-contractors to deliver the authorized products and services.

The total investment necessary to begin operation of a LIME Business is \$116,650 to \$161,875. This includes \$60,000 that must be paid to the franchisor or its affiliates.
