As a LIME PaintingTM franchisee, you will operate a business that utilizes a distinctive selling system to offer and sell painting and substrate services to designated residential and commercial customers, and that may coordinate with sub-contractors to deliver the authorized products and services.

The total investment necessary to begin operation of a LIME Business is \$116,650 to \$161,875. This includes \$60,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
