The franchise described in this disclosure document is for the establishment and operation of a Little Caesars® restaurant, which features pizza, chicken wings, Crazy Bread® products and other related products. You may purchase a single franchise or you may sign a territory reservation agreement that allows you to reserve a territory for potential development of a specified number of franchises.

The total investment necessary to begin operation of a single Little Caesars® restaurant franchise ranges from \$359,700 to \$1,686,000. This includes \$181,000 to \$285,000 that must be paid to us or our affiliate.

The total investment necessary for a territory reservation agreement, assuming it allows for development of four restaurants, ranges from \$21,000 to \$25,000, which is in addition to the cost of each single franchise to be developed. This includes \$20,000 (generally \$5,000 per Restaurant franchise) that you must pay to us as a Territory Reservation Fee.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
