The franchise is for a retail food establishment under the name "Loving Hut" offering vegan cuisine. The total investment necessary to begin operations of a Loving Hut franchise is \$83,000 - \$382,000. This includes \$15,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure documents at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

IN NOVEMBER 2012, THE FRANCHISOR ENTERED INTO A SETTLEMENT AGREEMENT WITH THE COMMISSIONER OF SECURITIES, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS OF THE STATE OF HAWAII REGARDING THE POTENTIAL VIOLATION OF HRS §4292E-3(c) - FILING A COPY OF THE OFFERING CIRCULAR WITH THE STATE AT LEAST SEVEN DAYS PRIOR TO THE SALE OF FRANCHISES

ON SEPTEMBER 7, 2012, THE FRANCHISOR AGREED TO ISSUE A NOTICE OF VIOLATION TO EACH CURRENT LOVING HUT RESTAURANT OWNER IN THE STATE OF CALIFORNIA, INFORMING THEM OF PAST VIOLATIONS OF THE CALIFORNIA FRANCHISE INVESTMENT LAW, DUE TO THE FRANCHISOR AND ITS PREDECESSOR'S FAILURE TO REGISTER OR OFFER DISCLOSURE AS REQUIRED BY STATE AND FEDERAL LAW

THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BE SETTLED BY MEDIATION OR BY LITIGATION. IF YOU SUE THE FRANCHISOR YOU MUST DO SO IN THE STATE OF CALIFORNIA. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE IN CALIFORNIA THAN IN YOUR HOME STATE
