We, Loyalty Networking, LLC d/b/a Loyalty Networking, offer a franchise opportunity to you as an Area Representative ("Area Representative"), to solicit, recruit and service franchises on our behalf, pursuant to an Area Representative agreement ("Area Representative Agreement") for a specified territory as described in the Schedule A to the Area Representative Agreement ("Territory").

You may purchase this franchise. If you pay the initial non-refundable franchise fee for each territory you wish to purchase and You execute the Agreement for each Territory, you will receive 50% of the initial Chapter Leader Service Fees and foyalties that we receive after the Effective Date of your Agreement from your Territory. The initial franchise fee is \$.00 to \$.50 per person in your Territory. The precise amount you pay per person will be negotiated based upon pertinent market factors as described below in Item 5. The minimum initial franchise fee that must be paid to us or our affiliates is \$0.00 per Territory. The total investment necessary to begin operation as a Loyalty Networking Area Representative is \$2,700 to \$356,900. This includes the initial franchise fee that you must pay to us.

The disclosure document summarizes certain provisions of your Area Representative Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

The terms of your Agreement will govern your franchise relationship. Don't rely on the disclosure document alone to understand your Agreement. Read all of your Agreement carefully. Show your Agreement to an advisor, such as a lawyer or accountant. Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1. THE AREA REPRESENTATIVE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN VIRGINIA. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO LITIGATE WITH US IN VIRGINIA THAN IN YOUR OWN STATE.
- 2. THE AREAREPRESENTATIVE AGREEMENT STATES THAT VIRGINIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. YOU AND WE AGREE TO WAIVE OUR RIGHTS TO A JURY TRIAL AND INSTEAD HAVE ANY LAWSUITS BETWEEN US DECIDED BY A JUDGE.
- 4. CONTINUATION OF YOUR RIGHTS TO BE AN AREA REPRESENTATIVE DEPENDS UPON YOUR ABILITY TO MEET THE MINIMUM SALES REQUIREMENTS WHICH YOU AND WE NEGOTIATE AND SPECIFY IN YOUR AREA REPRESENTATIVE AGREEMENT.
- 5. A SPOUSE NOT PARTY TO THE FRANCHISE AGREEMENT MAY BE REQUIRED TO GIVE A PERSONAL GUARANTY. BY SIGNING THE FRANCHISE AGREEMENT, A SPOUSE WILL BE JOINTLY AND SEVERALLY LIABLE, FOR ALL OBLIGATIONS OF THE FRANCHISE WHETHER OR NOT THE SPOUSE IS INVOLVED IN THE OPERATION OF THE FRANCHISE BUSINESS. THIS PLACES THE PERSONAL AND MARITAL ASSETS OF THE OWNERS AND THE OWNERS' SPOUSE AT RISK.



THERE MAY BE OTHER RISKS CONCERNING THE FRANCHISE.

We use the services of one or more FRANCHISE BROKERS of referral sources to assist us in selling our franchise. A franchise broker of referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us ("Franchise Broker"). You should be sure to do your own investigation of the franchise.
