The franchisee will operate a cafeteria style food service facility.

The initial franchise fee is Fifty Thousand Dollars \$50,000 for LunchStop Franchise and Twenty Thousand Dollars \$20,000 for LunchStop Express Franchise. The estimated initial investment required ranges from \$43,990 to \$131,337.
