The total investment necessary to begin operation of a Luxury Limo Group vehicle rental franchise ranges from \$129,700 to \$195,500. This includes \$25,000 to \$152,000 that must be paid to the franchisor or an affiliate.

You must receive this disclosure document at least 14 calendar days before you sign a binding agreement or make any payment in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
