The franchise will offer children's education and entertainment specializing in interactive science activities and scientific demonstrations.

The total investment necessary to begin operation of a Mad Science franchise (Standard) is \$69,200 to \$80,200. This includes \$48,500 that must be paid to the franchisor. The total investment necessary to begin operation of a Mad Science franchise (Home Based franchise) is \$49,400 to \$60,400. This includes \$34,500 that must be paid to the franchisor.
