The franchise offered is for the establishment and operation of either a Magic Brow Model A Unit, which will offer customers eyebrow threading and esthetician services, along with an assortment of retail beauty items, or a Magic Brow Model B Unit, which will only offer eyebrow threading services, with each model providing high quality services at reasonable prices in a warm and inviting atmosphere

The total investment necessary to begin operations of a Magic Brow Model A franchise is \$116,167 to \$216,500. This includes \$35,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operations of a Magic Brow Model B franchise is \$87,167 to \$167,833. This includes \$30,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
