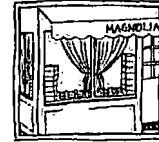

You will establish and operate within a defined territory multiple **MAGNOLIA BAKERY®** retail stores specializing in hand crafted classic American desserts, coffee, tea and related items.

The total investment necessary to begin operation of a **MAGNOLIA BAKERY®** retail store is from \$469,500 to \$935,000 for a full format retail store and \$211,750 to \$432,000 for a kiosk. This includes \$50,500 to \$125,500 for a full format retail store and \$24,950 to \$83,900 for a kiosk that must be paid to the franchisor or affiliate.

The franchise agreement we offer incorporates a multi-unit development agreement. You will pay us a non-refundable development fee when you sign the franchise agreement equal to \$30,000 for each of the first two full format retail stores you must open under your development schedule plus \$15,000 multiplied by the number of full format retail stores that you must open after the first two under your development schedule. The development fee paid for a particular retail store will be applied toward the initial franchise fee for the retail store payable when the retail store opens. The development fee is paid to the franchisor.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. More information on franchising, such as "*A Consumer's Guide to Buying a Franchise*," which can help you understand how to use this Disclosure Document, is available from the Federal Trade Commission. Your state may have a franchise law that requires a franchisor to register or file with a state franchise administrator before offering or selling in your state. MANY FRANCHISE AGREEMENTS DO NOT ALLOW YOU TO RENEW UNCONDITIONALLY AFTER THE INITIAL TERM EXPIRES. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE MASTER FRANCHISE AND DEVELOPMENT AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN NEW YORK. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN NEW YORK THAN IN YOUR OWN STATE.
2. THE MASTER FRANCHISE AND DEVELOPMENT AGREEMENT STATES THAT NEW YORK LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. YOU WILL BE SUBJECT TO A DEVELOPMENT SCHEDULE UNDER THE MASTER FRANCHISE AND DEVELOPMENT AGREEMENT. WE MAY TERMINATE YOUR DEVELOPMENT RIGHTS, REDUCE THE SIZE OF YOUR TERRITORY OR THE NUMBER OF STORES TO BE DEVELOPED, OR TERMINATE YOUR EXCLUSIVE RIGHTS IN THE DEVELOPMENT TERRITORY FOR YOUR FAILURE TO MEET THE DEVELOPMENT SCHEDULE.
4. AS STATED IN ITEM 12, IF YOU FAIL TO COMPLY WITH YOUR DEVELOPMENT SCHEDULE, WE MAY TERMINATE YOUR DEVELOPMENT RIGHT IN THE ENTIRE TERRITORY.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
