The franchisee will operate a business that provides supervised team cleaning services to homes and offers proprietary and other household products for sale using the trade name "MAID BRIGADE[®]."

The total investment necessary to begin operation of a Maid Brigade franchise business is between \$85,000 and \$124,000. This includes between \$28,000 and \$45,000 that must be paid to the franchisor and its affiliates.
