The total investment necessary to begin operation of a MAIDPRO Select Market Franchised Business is from \$74,560 to \$98,300, which includes the \$17,000 to be paid to the franchisor. The total investment necessary to begin a MAIDPRO Select Market Franchised Business if you are a qualified service veteran of the United States armed forces is \$71,560 to \$95,300, which includes \$14,000 that must be paid to the franchisor. The total investment necessary to begin a MAIDPRO Select Market Conversion Franchised Business is \$57,560 to \$81,300, which includes the waiving of the franchise fee that must be paid to the franchisor.
