The total initial investment necessary to begin operation of a Manhattan Bagel restaurant franchise ranges from \$481,200 to \$704,700 This includes \$40,200 to \$50,200 that is paid to us or our affiliate(s)

If you enter into an area development agreement, the development fee will be \$10,000 for each Manhattan Bagel Restaurant to be opened under that agreement

You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
