A "Manhattan Bagel" franchisee will operate a business (a "Manhattan Bagel Restaurant") that specializes in the sale of fresh-baked bagels, muffins, cookies, cream cheese and other spreads, specialty coffees and teas, and creative soups, salads and sandwiches, among other things.

The total initial investment necessary to begin operation of a Manhattan Bagel restaurant franchise ranges from \$481,200 to \$704,700. This includes \$40,200 to \$50,200 that is paid to us or our affiliate(s).

If you enter into an area development agreement, the development fee will be \$10,000 for each Manhattan Bagel Restaurant to be opened under that agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
