As a franchisee, you will operate a quick service restaurant business to provide innovative meals to the general public.

- 1. The total investment necessary to begin operation of a MAOZ VEGETARIAN franchise ranges from \$282,000 to \$598,500 for a start-up franchisee and \$261,000 to \$556,500 for a conversion franchisee. This includes the initial franchise fee, which for a start-up franchise or a conversion franchise is \$25,000 that must be paid to us.
- 2. This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 3. The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
- 4. Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE MOST DISPUTES WITH US BY LITIGATION ONLY IN FLORIDA. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN FLORIDA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN INITIAL INVESTMENT RANGING FROM \$282,000 TO \$598,500 FOR A START UP FRANCHISE AND FROM \$261,000 TO \$556,500 FOR A CONVERSION FRANCHISE. THIS AMOUNT EXCEEDS THE FRANCHISOR'S MEMBER'S EQUITY OF \$20,000 AS OF FEBRUARY 22, 2016.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
