The franchisee will operate a gourmet carry-out Italian restaurant, offering ready-to-serve meals in individual and group portion sizes.

The total investment necessary to begin operation of a Marino's Bistro ToGo franchise ranges from \$271,059 - \$412,363. This includes \$25,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
