The franchise offered is for the operation of a Martinizing retail dry cleaning store offering retail dry cleaning services, as well as dry cleaning and laundry pickup and delivery services, and dry cleaning and laundry services through both locker based and on-demand systems

The total investment necessary to begin the operation of a Martinizing franchise is from \$445,600 to \$675,100. This includes a \$69,500 initial franchise fee, \$318,600 initial package fee, a \$15,000 grand opening deposit, and shipping and taxes ranging from \$0-43,100 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
