Massage Heights businesses provide professional therapeutic massage and facial services to the general public through membership-based programs, and the sale of related products and services ("<u>MH Business</u>"). Franchisees may choose to become an area developer under an area development agreement which grants the right to establish and operate a certain number of MH Businesses in a specified area ("<u>Area Developer</u>").

The total investment necessary to begin operation of a MH Business is \$369,141 to \$609,161 which includes between \$127,000 and \$155,400 which must be paid to the franchisor or its affiliates. Area Developers must pay the initial franchise fees in full to franchisor at the time they sign the Area Development Agreement, along with the costs associated with opening a retreat.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make a payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
