The franchise offered is for a Medi-Weightloss® Businesses that, using our Marks, Copyrights and our System, offers our proprietary weight loss, wellness, nutritional and weight management products, services and programs.

The total initial investment necessary to begin operation of a Medi-Weightloss® Business ranges from \$180,084 to \$286,084. This includes \$150,000 to \$160,000 that must be paid to the franchisor and its affiliates. The total initial investment necessary to begin operation of a Development Business ranges from \$255,084 to \$436,084. This includes \$225,000 to \$310,000 that must be paid to the franchisor and its affiliates.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
