The Franchise offered is for the operation of a retail pharmacy under the Medicap Pharmacy® name and marks.

The total investment necessary to begin operation of a new Medicap Pharmacy[®] business is between \$330,050 and \$693,129. This includes between \$95,000 and \$187,655 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Medicap Pharmacy[®] business converted from an existing pharmacy is between \$5,000 and \$380,129. This includes up to \$67,655 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
