The total investment necessary to begin operation of a new Medicap Pharmacy® business is between \$330,050 and \$693,129. This includes between \$95,000 and \$187,655 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Medicap Pharmacy® business converted from an existing pharmacy is between \$5,000 and \$380,129. This includes up to \$67,655 that must be paid to the franchisor or its affiliates.
