The franchise offered is to operate a Mellow Mushroom® restaurant, which features pizza and sells other food products, clothing, souvenirs, and novelty items.

The total investment necessary to begin operation of a Mellow Mushroom[®] restaurant franchise ranges from $\frac{1,036,5001,075,500}{1,075,500}$ to $\frac{1,544,0001,556,000}{1,556,000}$ if you lease shell premises for the Restaurant, from $\frac{1,036,5001,088,500}{1,088,500}$ to $\frac{1,744,0001,777,000}{1,777,000}$ if you lease premises for the Restaurant that must be retrofit, and from $\frac{1,904,5001,953,500}{1,953,500}$ to $\frac{3,337,0003,379,000}{3,379,000}$ if you buy the real estate upon which you will construct a new building for the Restaurant. This includes between \$86,000 and \$98,000 that must be paid to the franchisor or affiliate. If you want development rights, you generally must pay the franchisorus a development fee equal to \$50,000 (the initial franchise fee for the first Restaurant) plus a deposit of \$25,000 for each additional Restaurant.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
