The franchise offered is to operate a Mellow Mushroom® restaurant, which features pizza and sells other food products, clothing, souvenirs, and novelty items.

The total investment necessary to begin operation of a Mellow Mushroom® restaurant franchise ranges from ~~\$1,408,000 to \$2,136,500~~ 1,533,500 to \$2,245,500 if you lease shell premises for the Restaurant, from ~~\$1,493,000 to \$2,266,500~~ 1,608,500 to \$2,370,500 if you lease premises for the Restaurant that must be retrofit, and from ~~\$2,351,000 to \$4,008,500~~ 2,703,500 to \$4,462,500 if you buy the real estate upon which you will construct a new building for the Restaurant. This includes between \$105,600 and \$118,600 that must be paid to the franchisor or affiliate. If you want development rights, you must pay us a development fee equal to \$50,000 (the initial franchise fee for the first Restaurant) plus a ~~deposit of~~ \$25,000 deposit for each additional ~~Restaurant~~ Restaurant's initial franchise fee.
