The franchise offered is to operate a Mellow Mushroom® restaurant, which features pizza and sells other food products, clothing, souvenirs, and novelty items.

The total investment necessary to begin operation of a Mellow Mushroom® restaurant franchise ranges from \$1,609,000 to \$2,376,000 if you <u>lease</u> shell premises for the Restaurant, from \$1,609,000 to \$2,576,000 if you <u>lease</u> premises for the Restaurant that must be retrofit, and from \$2,809,000 to \$4,473,000 if you <u>buy</u> the real estate upon which you will construct a new building for the Restaurant. This includes between \$78,000 and \$88,500 that must be paid to the franchisor or affiliate. If you want development rights, you must pay us a development fee equal to \$50,000 (the initial franchise fee for the first Restaurant) plus a \$25,000 deposit for each additional Restaurant's initial franchise fee.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

THE PRELIMINARY AGREEMENT AND FRANCHISE AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN THE CITY AND STATE WHERE WE HAVE OUR PRINCIPAL BUSINESS ADDRESS WHEN THE ACTION IS COMMENCED (IT CURRENTLY IS IN ATLANTA, GEORGIA). OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN OUR HOME CITY AND STATE THAN IN YOUR OWN STATE.
- 2. THE PRELIMINARY AGREEMENT AND FRANCHISE AGREEMENT REQUIRE THAT GEORGIA LAW GENERALLY GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
