The franchisee will operate a MEN IN KILTS franchised business (“Franchised Business”) which provides window cleaning, gutter cleaning, pressure washing, siding cleaning, snow removal and other related services.

The total investment necessary to begin operation of a MEN IN KILTS Select Market Franchised Business is from \$73,135 to \$102,650, which includes the \$17,000 to be paid to the franchisor. The total investment necessary to begin a MEN IN KILTS Select Market Franchised Business if you are a qualified service veteran of the United States armed forces is \$70,135 to \$99,650, which includes \$14,000 that must be paid to the franchisor. The total investment necessary to begin a MEN IN KILTS Select Market Conversion Franchised Business is \$56,135 to \$85,650, which includes the waiving of the franchise fee that must be paid to the franchisor.

The total investment necessary to begin operation of a MEN IN KILTS Enterprise Market Franchised Business is from \$97,785 to \$146,900 which includes the \$34,000 to be paid to the franchisor. The total investment necessary to begin a MEN IN KILTS Enterprise Market Franchised Business if you are a qualified service veteran of the United States armed forces is \$94,785 to \$143,900, which includes \$31,000 that must be paid to the franchisor. The total investment necessary to begin a MEN IN KILTS Enterprise Market Conversion Franchised Business is \$63,785 to \$112,900, which includes the waiving of the franchise fee that must be paid to the franchisor.

The total investment necessary to begin operation of a MEN IN KILTS Multi-Unit Enterprise Market Franchised Business is from \$151,635 to \$211,150 which includes the \$68,000 to be paid to the franchisor.
