As a MEN IN KILTS franchisee you will operate a business which provides window cleaning, gutter cleaning, pressure washing, siding cleaning, snow removal and other related services ("the Men In Kilts System") ("Franchised Business").

The total investment necessary to begin operation of a MEN IN KILTS Select Market Franchised Business ranges from \$75,135 to \$114,650, which includes an Initial Franchise Fee of \$17,000 that must be paid to the Franchisor or affiliate. The total investment necessary to begin a MEN IN KILTS Select Market Conversion Franchised Business ranges from \$58,135 to \$97,650, which includes the waiving of the Initial Franchise Fee that must be paid to the Franchisor or affiliate.

The total investment necessary to begin operation of a MEN IN KILTS Enterprise Market Franchised Business ranges from \$99,785 to \$158,900 which includes an Initial Franchise Fee of \$34,000 that must be paid to the Franchisor or affiliate. The total investment necessary to begin a MEN IN KILTS Enterprise Market Conversion Franchised Business ranges from \$65,785 to \$124,900, which includes the waiving of the Initial Franchise Fee that must be paid to the Franchisor or affiliate.

The total investment necessary to begin operation of a MEN IN KILTS Multi-Unit Enterprise Market Franchised Business ranges from \$153,635 to \$223,150, which includes an Initial Franchise Fee of \$68,000 that must be paid to the Franchisor or affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in the document.**
