The franchise offered is for the establishment and operation of a business providing interior and exterior painting, wallcovering, staining and other specialty wood finishes, water-proofing, specialty caulking, traffic coatings, epoxy coatings and other related services to commercial customers.

The total investment necessary to begin operations of a Merit Professional Coatings franchise is \$104,383 to \$148,425. This includes \$25,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operations of a conversion franchise is \$38,650 to \$52,125. This includes \$15,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES THAT MOST DISPUTES BE SUBMITTED TO ARBITRATION IN HILLSBOROUGH COUNTY, FLORIDA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN FLORIDA THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND FLORIDA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. FOR CALIFORNIA, A FEE DEFERRAL HAS BEEN IMPOSED BY THE CALIFORNIA DEPARTMENT OF CORPORATIONS DUE TO THE FRANCHISOR'S FINANCIAL CONDITION.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
