The franchisee will engage in the business of owning and operating a MERLIN 200,000 MILES SHOP which specializes in vehicle longevity, preventive maintenance, and in the repair and replacement of brake systems and components, motor vehicle muffler and exhaust systems, ride control components, tires, and other motor vehicle services.

The estimated total initial investment for a MERLIN 200,000 MILES SHOP ranges from \$251,200 to \$408,000, including \$55,000 to \$80,000 you must pay the Franchisor.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale.
