The franchise offered is for the operation of an off-sale retail liquor store. The total investment necessary to begin operation of an MGM Wine & Spirits® store is estimated at between \$274,000 and \$2,017,000. This includes an initial franchise fee that must be paid to us of either \$75,000, or a reduced initial franchise fee of \$40,000 if (i) the franchised store is located in a state that does not already have 2 MGM Wine & Spirits® stores open in the state at the time that you purchase the franchise, or (ii) this is the second or subsequent MGM franchise you are acquiring, and you are not in default under your current franchise agreement(s).

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind.
