The franchisee will operate a business within a designated territory that sells and distributes automotive replacement parts, supplies, chemicals and other maintenance products.

The total investment necessary to begin operation of a Mighty franchised business is between \$144,100 and \$372,400. This includes from \$45,500 to \$100,000 that must be paid to the Franchisor or its affiliates.

OUT OF STATE MEDIATION AND/OR ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND/OR ARBITRATE WITH US IN GEORGIA THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT THE LAW OF GEORGIA GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. YOU MUST GRANT US A PRIORITY SECURITY INTEREST IN ALL PRESENT AND FUTURE ACCOUNTS RECEIVABLE AND INVENTORY IN THE FRANCHISE. THIS SECURITY INTEREST MAY IMPAIR YOUR ABILITY TO OBTAIN FINANCING FOR YOUR OPERATIONS.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
