The total investment necessary to begin operation of a single MILIO'S Restaurant ranges from \$121,460 to \$313,100 for convenience store locations and from \$154,900 to \$386,300 for in-line or free standing locations. This includes \$30,300 to \$52,800 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale.
