Textile and Carpet Care

The franchise offered is for a MilliCare Textile and Carpet Care business which will provide cleaning and maintenance of floor coverings, interior finishes and interior furnishings, and related services in commercial, industrial, and office properties.

The total investment necessary to begin operation of a new MilliCare franchise is \$110,300 to \$152,500, but it may be lower for an existing business that is already incurring some of the overhead costs required for the initial investment. This includes, for a new franchise, \$25,000 that must be paid to us as an initial franchise fee, \$2,000 that must be paid to us as an initial training fee, and \$31,000 that must be paid to us for a start-up package of equipment and materials.

If you are already a MilliCare franchisee and are buying an additional MilliCare franchise, the initial franchise fee will be \$20,000; there will not be an initial training fee, and you will not have to buy a start-up package of equipment and materials if your new Marketing Area will be contiguous to your existing Marketing Area. If you are purchasing a MilliCare franchise for a secondary market, the initial franchise fee will be \$15,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

- 1. THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE TO ARBITRATE WITH US ONLY IN THE STATE OF SOUTH CAROLINA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN SOUTH CAROLINA THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT REQUIRES THE FRANCHISEE TO RESOLVE CLAIMS THAT ARE NOT SUBJECT TO ARBITRATION BY LITIGATION ONLY IN OR NEAR SPARTANBURG, SOUTH CAROLINA. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO LITIGATE WITH US IN SOUTH CAROLINA THAN IN YOUR HOME STATE.
- 3. THE FRANCHISE AGREEMENT STATES THAT DELAWARE LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 4. YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY. WE MAY ESTABLISH OTHER FRANCHISED OR COMPANY-OWNED BUSINESSES THAT WILL COMPETE WITH YOUR BUSINESS.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
