Mirror Clan, Inc , a California corporation, offers franchises for the operation of OneTaste personal growth educational centers that offer lectures, classes, workshops, exercises, coaching services and other selected instructional programs about orgasmic meditation. We offer the rights for 2 different franchises in this Disclosure Document

<u>Single Business Program</u> Under the Single Business Program, you will sign a Franchise Agreement to operate a single OneTaste Business under the OneTaste Marks and in accordance with the OneTaste System. The total investment necessary to begin operations of a single OneTaste Business ranges from approximately \$34,750 to \$73,000. This includes \$15,000 that must be paid to us or our affiliate, OneTaste Incorporated.

Area Development Program Under the Area Development Program, we assign you a defined area within which you must develop and operate a minimum of 2 OneTaste Businesses within a specified period of time. The total investment necessary to develop 2 OneTaste Businesses under an Area Development Agreement ranges from approximately \$44,750 to \$83,000. This includes between \$25,000 that must be paid to us or our affiliate, OneTaste Incorporated

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
