The franchisee will operate a specialty women's retail clothing and accessory store. The total estimated investment necessary to begin operation of a MkLAREN franchise will range from \$200,000 to \$478,000. (See Item 7) This includes the initial franchise fee of \$45,000 that must be paid to the franchisor.

This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT PERMITS YOU TO ARBITRATE WITH US OR SUE US ONLY IN THE STATE WHERE OUR PRINCIPAL PLACE OF BUSINESS IS LOCATED (CURRENTLY, BOZEMAN, MONTANA). OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US OR SUE US IN MONTATA THAN IN YOUR HOME STATE. YOUR STATE LAW MAY SUPERCEDE THIS PROVISION AND IT MAY NOT BE ENFORCEABLE IN YOUR STATE.

IF OUR RIGHT TO USE THE TRADEMARK IS CHALLENGED, YOU MAY HAVE TO CHANGE TO AN ALTERNATIVE TRADEMARK, WHICH MAY INCREASE YOUR EXPENSES.
