You will operate a Moe's Southwest Grill® restaurant (a "Restaurant"). Moe's Southwest Grill® Restaurants are fast casual restaurants featuring southwestern food products.

The total investment necessary to begin operation of a Moe's Southwest Grill® franchise ranges from \$457,400 to \$911,500. This total investment estimate includes \$30,000 to \$30,400 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
