Momma G's, Inc. offers franchises for Momma Goldberg's Deli restaurants. Momma Goldberg's Deli restaurants are quick-serve restaurants featuring a limited menu of specialty sandwiches including our signature "Momma's Love" sandwich, salads and soups and emphasizing prompt and courteous service in a clean, wholesome atmosphere.

The initial franchise fee for a Momma Goldberg's Deli restaurant is \$25,000. The estimated initial investment for a Momma Goldberg's Deli restaurant is \$200,700 to \$726,000 (see Item 7).

The total investment necessary to begin operation of a Momma Goldberg's Deli restaurants is \$281,200 to \$767,000. This includes \$25,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
