Monkey Bizness® businesses provide indoor play and party centers for children which feature inflatable play structures, rock climbing walls, interactive games, and the sale of related products (“**MB Business(es)**”).

The total estimated investment necessary to begin operation of our standard MB Business is between \$431,000 and \$668,500, including between \$42,500 and \$52,500 that must be paid to the franchisor or its affiliates. We also offer MB Businesses that operate in a retail environment offering a café area for parents. The total investment necessary to begin operation of a retail MB Business is between \$328,000 and \$572,500, including between \$39,500 and \$52,500 that must be paid to the franchisor or its affiliates. This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
