The franchisee will operate a tree care business under the name and mark "Monster Tree Service<sup>®</sup>", which features tree and shrub care that utilizes state-of-the-art equipment which provides the ability to safely and proficiently prune or remove any tree, regardless of size, location, or condition.

The total investment necessary to begin operation of a Monster Tree Service franchise ranges from \$121,395 to \$243,495. This includes \$41,495 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO LITIGATE WITH US ONLY IN MONTGOMERY COUNTY, PENNSYLVANIA. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT ALSO MAY COST MORE TO LITIGATE WITH US IN PENNSYLVANIA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES PENNSYLVANIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE FRANCHISE AGREEMENT REQUIRES YOU TO PAY LIQUIDATED DAMAGES IF YOU FAIL TO OPEN YOUR BUSINESS WITHIN THE SPECIFIED TIMEFRAME OR IF YOUR FRANCHISE AGREEMENT IS TERMINATED FOR CAUSE.
- 4. FRANCHISOR AND FRANCHISEE AGREE TO WAIVE THE RIGHT TO A JURY TRIAL AND WAIVE THE RIGHT TO BE AWARDED EXEMPLARY, PUNITIVE, OR CONSEQUENTIAL DAMAGES.
- 5. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$121,395 to \$243,495. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2013, WHICH IS 58,690.
- 6. THE FRANCHISE AGREEMENT REQUIRES YOU TO MAKE MINIMUM ANNUAL SALES AND PAY MINIMUM ROYALTIES ASSOCIATED WITH THOSE SALES. THE MINIMUM ANNUAL SALES FOR YEAR 1 ARE \$175,000, WHICH IS \$11,375 IN ROYALTIES; YEAR 2 ARE \$350,000, WHICH IS \$21,125 IN ROYALTIES; AND YEAR 3 AND BEYOND ARE \$500,000, WHICH IS \$32,500 IN ROYALTIES. FAILURE TO MAKE PAYMENT OF ROYALTIES IS A DEFAULT AND MAY RESULT IN TERMINATION OF THE FRANCHISE AGREEMENT.
- 7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We currently use the services of FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
