The franchisee will operate a tree care business under the name and mark “Monster Tree Service®”, which features tree and shrub care that utilizes state-of-the-art equipment which provides the ability to safely and proficiently prune or remove any tree, regardless of size, location, or condition.

The total investment necessary to begin operation of a Monster Tree Service franchise ranges from ~~\$137,656~~ ~~to \$118,042~~ - ~~\$213,266~~ \$18,581. This includes \$40,120 to 41,495 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, ~~2014~~2015, WHICH IS ~~\$70,73589,594~~. FRANCHISOR HAS LIMITED FINANCIAL RESOURCES WHICH MIGHT NOT BE ADEQUATE TO FUND ITS PRE-OPENING OBLIGATIONS TO EACH FRANCHISEE AND PAY OPERATING EXPENSES.
6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
