The franchisee will operate a business under the name and mark “Monster Tree Service[®],” which features tree care and plant healthcare services.

The total investment necessary to begin operation of a Monster Tree Service franchise ranges from \$160,815 to \$266,429. This includes the \$49,500 that must be paid to the franchisor.
