Montessori School Franchising LLC is offering franchises for the operation of Montessori Kids Universe schools that provide childcare and early childhood education based upon on the implementation of a Montessori inspired curriculum. The curriculum is enhanced through the inclusion of our Reggio Emilia inspired educational program.

The total investment necessary to begin operations of a Montessori Kids Universe school is \$426,511 to \$933,671. This fee includes between \$61,000 and \$69,000 that must be paid to the franchisor or its affiliates. The franchisor may offer to qualified candidates the right to develop multiple Montessori Kids Universe schools under the terms of a Multi-Unit Development Agreement, in which case the total investment stated above will increase by an amount equal to \$10,000 times the number of additional Montessori Kids Universe schools to be developed under the Multi-Unit Development Agreement, which amounts are paid to the franchisor.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
