The franchise offered is for the operation of a MORANO GELATO® Shop, manufacturing and selling authentic Italian gelato made on site daily, in addition to offering other European specialty foods, beverages and sweets (“Shop” or “Franchised Business”). MORANO GELATO® franchisees provide authentic Italian gelato using both local and Italian ingredients to create traditional Italian gelato flavors.

The total investment necessary to begin the operation of a MORANO GELATO® Franchised Business is \$301,194 to \$533,709. This includes \$35,000 that must be paid to the franchisor or its affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in the document.**
