The franchises offered are for the operation of a More Space Place retail furniture store, specializing in space-saving furniture products, some of which are proprietary or the operation of a Closet & Storage Concepts business providing for the designing marketing, construction and installing of residential and commercial storage space including closets, garages, and other storage areas for consumers and the selling of related accessories either in a retail showroom or as a home based business

The total investment necessary to begin operation of a More Space Place franchised business is \$98,000 to \$165,000 This includes \$49,300 to \$65,100 that must be paid to the franchisor or its affiliate(s)

The total investment necessary to begin operation of a Closet & Storage Concepts franchised business is \$22,150 to \$197,200 This includes \$17,500 to \$38,500 that must be paid to the franchisor or its affiliate(s)

IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN MIDDLESEX COUNTY, NEW JERSEY THAN IT MAY COST IN YOUR OWN STATE OR AREA.

2 THE FRANCHISE AGREEMENT STATES THAT NEW JERSEY LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3 AS PER THE AUDITED BALANCE SHEET DATED DECEMBER 31, 2014, THE FRANCHISOR HAD A WORKING CAPITAL DEFICIENCY OF (\$70,321).

4 FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$22,150 TO \$197,200. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDER'S EQUITY AS OF DECEMBER 31, 2014, WHICH IS \$18,585.
