The franchisee will establish and operate a business, which offers a seasonal business controlling undesirable outdoor insects, such as mosquitoes, ticks and fleas, including the sales, design, installation and servicing of outdoor misting systems, barrier spray services, and other insect elimination and control systems for both residential and commercial applications using the trade name "Mosquito Joe®."

The approximate total investment necessary to begin operation of a single Mosquito Joe® franchise business is currently \$62,850 to 69,600 to \$125,750122,500. This includes \$30,750 to 40,000 to \$63,75060,000 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of an area development Mosquito Joe franchised business is \$35,00045,000 to \$95,000. This includes \$35,00045,000 to \$95,000 that must be paid to the franchisor.
