The franchise is for the operation of a Motel 6® motel offering limited services and limited amenities, designed to compete directly with other brands in the budget segment of the lodging market (“Motel 6 Motel” or “Motel”).

The total investment necessary to begin operation of a newly constructed 63 room Motel 6 Motel (excluding land acquisition costs) is \$41,550 to \$61,326. This includes \$35,000 to \$70,000, which must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
