Mountain Man Nut & Fruit Co. was formed in 1978 for the purpose of packaging and distributing nuts, dried fruits, trail mixes, candy and snack foods. This is done through a network of distributors (franchisees) working in specific areas and delivering product at regular intervals to consumers at their place of employment.

The total investment necessary to being operation of a Mountain Man Nut & Fruit Co. franchise is \$15,900. This includes \$7500 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or made any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
