Mr Brews Taphouse® Restaurants are restaurants featuring a variety of craft beer selections and high-quality hamburgers served on bakery fresh buns along with other food and beverage products in a distinctive, casual and family-friendly atmosphere.

The total investment necessary to begin operation of a franchised Mr Brews Taphouse® Restaurant is \$341,500 to \$674,000. This includes an Initial Fee of \$30,000 that must be paid to the franchisor. If you enter into an Area Development Agreement, you must also pay a Development Fee to the franchisor equal to 25% of the Initial Fees for the Mr Brews Taphouse® Restaurants that you are required to develop under the Area Development Agreement.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this Disclosure Document.

The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. More information on franchising, such as "A Consumer's Guide to Buying a Franchise," which can help you understand how to use this Disclosure Document, is available from the Federal Trade Commission (the "FTC"). OUT-OF-STATE MEDIATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT OF DISPUTES.
