As a franchisee, you will sell service and repair electrical systems, equipment, components and supplies, including installation, upgrades and remodeling for residential and commercial customers.

The total investment necessary to begin operation of a Mr. Electric® franchise ranges from \$83,900 to \$189,000, plus any additional franchise fee or real estate costs, as described in Item 7. This includes \$29,599 (\$28,000 initial fee + \$1,599 software fee) that must be paid to the franchisor and our affiliate, ZorWare. It does not include fees for additional territory (beyond the minimum 100,000), for which we charge \$280 per 1,000 population, or fees for additional named software users (beyond 3 named users accessing our proprietary software, ZWare) for which our affiliate, ZorWare, charges \$175 for the next (4th) named user and \$75 for a fifth (5th) named user. You should determine any additional charges applicable to you based on the territory population and number of named users you plan to have. See Items 5 and 6.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
