Multivista Franchise-Systems LLC is offering franchises for the operation of a business which provides construction documentation and related-other approved products and services.

The total estimated initial investment necessary to begin operation of a Multivista franchise ranges from \$84,500-<u>88,000</u> to \$363,000,000. This includes \$24,000-<u>25,350</u> to \$108,500-<u>154,450</u> that must be paid to the franchisor or affiliate. See Items 5, 6 and 7.

We also grant to qualified persons the right to a specific geographic area(s) in which to develop a predetermined number of Businesses under a Multi-Territory Development Agreement. If you execute a Multi-Territory Development Agreement, in addition to payment of the initial franchise fee for the first Business, you pay a nomefundable development fee equal to 0% to 15% of the initial franchise fee for each additional Business to be developed, which is later applied to the initial franchise fee due for the additional Business.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
